<b><u>Class B</u></b>	<b>Five Day Family Membership*</b> - Weekday play only. Weekday members wishing to play weekends must pay greens fees. If wishing to play weekend tournaments, must pay green fees and tournament fees with the only exception being Club Championships. Two votes by adult members.	<b>\$1,830</b>
<b><u>Class C</u></b>	<b>Young Adult Family Membership*</b> - Ages 18 through 35. Ages 18 through 35 (age as of 1/1/21). No playing restrictions. Two votes by adult members. Proof of age (i.e. copy of driver's license) must be submitted with the application or invoice payment.	<b>\$1,830</b>
<b><u>Class D</u></b>	<b>Seven Day Single Membership</b> - No playing restrictions. One vote allowed.	<b>\$1,400</b>
<b><u>Class E</u></b>	<b>Five Day Single Membership</b> - Weekday play only. Weekday members wishing to play weekends must pay green fees. If wishing to play weekend tournaments, must pay green fees and tournament fees with the only exception being Club Championships. One vote allowed.	<b>\$1,080</b>
<b><u>Class F</u></b>	<b>Young Adult Membership</b> - Ages 18 through 35 (age as of 1/1/21). No playing restrictions. One vote allowed. Proof of age (i.e. copy of driver's license) must be submitted with the application or invoice payment.	<b>\$1,185</b>
<b><u>Class G</u></b>	<b>College Student Membership-</b> Ages 18 through 22. No playing restrictions. No voting privileges. For those enrolled in college as a full-time student, proof of status must be submitted with the application and each year that classification is maintained.	<b>\$325</b>
<b><u>Class H</u></b>	<b>Junior Membership*</b> - Under age of 18, not part of family membership. Must list school attending and proposed high school graduation year. No voting privileges. No Weekends or holidays before noon.	<b>\$175</b>

<p>Any child of a Family Member (Class A, B &amp; C) may use the golf course facilities if the child meets the following:</p> <ul style="list-style-type: none"> <li>● Is eligible through the calendar year of high school graduation</li> <li>● Is residing at the Member's residence</li> <li>● Is enrolled as a full-time college student (age 22 or under)</li> <li>● Is a Member of the military (age 22 or under)</li> <li>● Is not married</li> </ul>	<p>Children playing under Family Member Classification are subject to the additional rules listed below:</p> <ul style="list-style-type: none"> <li>*All children under the age of 18 shall be classified as "Junior Golfers"</li> <li>*Junior Golfers may only participate in tournaments or events designated by the Board of Directors.</li> <li>*Children aged 18 through 22 per Section A above may participate in any tournament or event that is open to Members.</li> <li>*Children aged 10 through 17 years old – must have supervision on Saturdays, Sundays, and Holidays. Exceptions: must have Pro Shop approval.</li> <li>*Children aged 9 years old &amp; Under – must have adult supervision at all times on the premises and may not play before Noon on Saturdays, Sundays, and Holidays. Exceptions to play before Noon on Saturdays, Sundays, and Holidays may be granted to Junior Golfers who have passed a playing test given by the Golf Professional.</li> </ul>
